Seller makes no representation or warranty, expressed or implied, on the items for sale and does further state the items are to be sold "AS IS, WHERE IS" WITH NO WARRANTY OR GUARANTEE. The buyer acknowledges that he is relying solely on his or her inspection, and accepts all responsibility for examining any item offered for sale.

2. **ALL SALES FINAL. NO REFUNDS.**

3. All purchases must be paid for **in full** by noon on Wednesday, May 10, 2017 at the Sheriff's Office, 4th Floor-Courthouse, Franklin, La. A payment receipt will be issued and must be presented to the Motor Pool in order to pick up your item before Friday, May 12, 2017 between the hours of 9:00 a.m. and 3:00 p.m.
Cash, cashier's checks, certified check and money orders will be accepted and should be made payable to: *St. Mary Parish Sheriff's Office.*

4. **Buyer's Responsibilities:** Buyer assumes full responsibility for all items purchased when the sales is concluded. Seller is not responsible for security of items purchased, which include lost, stolen or damaged items. Items left on the premises are at buyer's risk. If payment is not made by noon on Wednesday, May 10, 2017 then the item will be awarded to the next bidder in line.

The buyer hereby assumes and does agree to indemnify and hold harmless the seller from any current or future claim which shall pertain to the fitness, use, damage, safety, injuries to persons or property that may have occurred during the inspection/preview period or that may have been caused by or during removal or use of items purchased.
