In March, Narcotics Division detectives arrested a Franklin man for manufacturing synthetic drugs in an investigation conducted in conjunction with the Lafayette Metro Narcotics Division. The subject was selling the illegal substances at an aromatherapy shop in Lafayette. During the search, narcotics detectives located a synthetic cannabinoid manufacturing operation including a designated area in the residence where the illegal substances were mixed and packaged for sale. (Above) Synthetic cannabinoids with an estimated street value of \$10,000, three hand guns, digital scales, approximately 10,000 small foil bags, over 5 pounds of green vegetative material, suspected synthetic cannabinoid powder, and large amounts of flavor sprays were seized during the Franklin bust. Detectives also seized over \$83,000 believed to be proceeds from illicit drug sales.

## CIVIL LIVE SCAN

This background check system allows private employers to submit an employment applicants fingerprints to the Federal Bureau of Investigations and Department of Public Safety to determine their eligibility to hold positions involving children, the elderly, or disabled. The checks verify if applicants have active warrants for arrest, an arrest record, or have been convicted of violent or sex offenses. Businesses that would like to utilize Live Scan must register through the Department of Public Safety. Parish background checks for individuals (not Civil Live Scan) are conducted at the Franklin dispatch office from 8am-4pm, Monday-Friday. A valid picture ID, original social security card, and \$15 money order is required.
